The updated enrollment forms & annual \$35.00 registration fee are due by **August 24th**. (The Center uses the fee to buy classroom supplies throughout the school year) Some tuition rates have increased slightly. The tuition rate chart shows the rates effective September 1st.

Luv, Learn-n-Laughter's preferred method of payment is automatic bank withdrawal through "Tuition Express". If you haven't already joined "Tuition Express", please consider completing the attached form.

If you are enrolled full-time only, your ten "Vacation Days" will begin again on September 1st and end on August 31st. You must give at least 24 hours notice, in writing, to use a "Vacation Day" .

Please provide any changes during the year (phone #, work location, someone different picking up, etc.) in writing. We cannot accept phone call pick-up authorizations.

TUITION PAYMENT AGREEMENT

Tuition is charged regardless of each child’s attendance. Tuition covers the enrollment position in each class and not days present. Tuition is non-refundable and rates are subject to change. No credit is given for absences or scheduled Center holidays with the following exceptions:

1. Full-Time enrolled children (September 1 to August 31) are given two weeks tuition free “vacation time” with prior office notice.
2. Full-Time enrolled children are given half cost tuition “sick time” when absent with a serious communicable disease for one full calendar week or more with a doctor’s note.

Please help us comply with the requirements of the United States Department of Agriculture's Child and Adult Care Food Program (CACFP) by completing the attached income eligibility application for free and reduced-price meals. All information will be treated with strict confidentiality.
